POST-EMERGENCE CORN - Broadleaf Control

Solstice herbicide brings a new level of activity due to the complimentary activity resulting from having a PPO herbicide and HPPD herbicide together. This is one of the first combinations of its kind for use in corn.

With **Solstice herbicide**, weed control is much faster as well as more complete than either herbicide alone. The combination provides a stronger resistance management tool by combining the two A.I.'s into a single, effective herbicide for use in all corn types.



Solstice Herbicide Use Directions

Rate: 2.5 – 3.15 fl. oz./A: Spike stage to V8 corn

Recommended Treatments

- Solstice herbicide 3.0 - 3.15 oz. + Roundup[®] herbicide 22-44 oz.
- Solstice herbicide 2.5 – 3.15 oz. + atrazine 0.5 lb a.i. + Roundup herbicide
- Solstice herbicide 2.5 – 3.15 oz. Status[®] herbicide

Adjuvants: COC 0.5% v/v or NIS - 0.25% v/v. + AMS 8.5 lb/100 gal or UAN – 2.5 gal/100 gal

- COC is preferred adjuvant for maximum weed control
- Liberty[®] herbicide tank-mixes – only add AMS. No COC or added NIS
- MSO is not recommended with Solstice herbicide

Application Guidelines:

- Ground Application only: 10-30 gallons per acre

Precautions:

- Avoid applications with wet foliage, cold (50's), damp conditions with slow growing conditions

One-Pass Post-Emergence Option

Solstice herbicide 2.5 oz. + Anthem MAXX herbicide 2.0 oz. + atrazine 1 pt. + glyphosate 1 lb ai + NIS 1-2 qt/100 gal + AMS

- Combines the post strength of Solstice herbicide with Additional Residual of Anthem MAXX herbicide through crop canopy
- Apply early post: V1 - V4 stage corn

Potatoes and alfalfa – 10 month
All other crops – 18 months
