One Pass Early Postemergence Programs (< 4" Weeds but Prior to 12" Corn)

Anthem[®] MAXX herbicide @ 2.0 oz./A
 + Solstice[®] herbicide @ 2.5 oz./A
 + Atrazine @ 0.5 - 1.5 lbs./A
 + Glyphosate **or** glufosinate (at recommended rates)

or

Anthem MAXX herbicide* 3 - 4 oz.
 + Atrazine 1.0 – 2.0 lbs./A
 + Glyphosate **or** glufosinate (at recommended rates)

One-Pass Preplant Programs

Anthem MAXX herbicide @ 3-4 oz./acre
Pre-plant burndown tank-mix partners at local burndown rates:

+ 2,4-D + glyphosate + Aim[®] EC herbicide
 1.0 - 1.5 oz./A

+ Glufosinate
